- Contract awarded to AMCA in 2016
 - Establish training and certificate programs for mosquito surveillance and control
 - In response to emergence and spread of Zika
- Three track training approach
 - Updated Best Management Practices for Integrated Mosquito Management Manual
 - Online and onsite components
 - 10 regional training hubs across the US
 - 18 Master Trainers

Track 1: eLearning Modules

- Covers topics such as historical information about Zika and related vectors, Aedes species ecology, behavior, surveillance, and control
- Interactive, natural exchange of information; modules "tell the story"
- Audio based on conversation: Andy and Lindsey
- Bring learner into conversation through questions
- Immediate feedback for answers, plus logic
- Graphics and visual vehicles
- Scored evaluation at end (must answer 85% correct to pass)
- Seat time of 30 to 60 minutes
